Now comes General Teamsters Local 179 (“Local 179”) and, pursuant to 56 Illinois Administrative Code, Section 120.320, moves to intervene in this proceeding. In support of this motion, Local 179 states as follows:

1. On or about June 28, 2010 Petitioner requested a Section 9 hearing for the purpose of establishing and reclassifying various prevailing wage classifications for operating engineers.

2, Local 179's geographical jurisdiction includes part of the area involved in the Petition.

3. Certain of the classifications referenced in the Petition, including but not limited to "Straight Framed Truck", may involve equipment operated by Teamsters and which come under Teamsters' prevailing wage classifications.

4. Local 179 may be adversely affected by a final order resulting from the hearing.

WHEREFORE, Local 179 requests that it be allowed to intervene in the hearing.


