<u>General Duties</u>: A Veterans Service Officer is responsible for either managing or co-managing a field office involved in preparing and presenting benefit claims for military personnel, veterans, their dependents and/or survivors or as an itinerant officer in field offices. The employee consults and corresponds with clientele and the community on an ongoing basis relative to law changes, amendments and deletions which may affect eligibility or the policy of any number of given veterans programs. This individual in this position also interviews and advises clientele, and researches applicant military, social, educational, vocational and medical histories to gather information to develop and support benefit claims. The employee is responsible for preparation of informational bulletins for release to the news media and the general public and works to develop and maintain liaison with state, federal and community organizations involved in veterans' affairs.

<u>Minimum Training & Experience</u>: Requires knowledge, skill and mental development equivalent to the completion of two years college with an emphasis in business administration or public administration **and** one year of experience in sales, public relations, welfare work or other work involving extensive public contact.

The applicant must also possess an honorable discharge from service in the Armed Forces of the United States **and** must have served during a time of hostilities with a foreign country meeting one or more of the following conditions:

- 1) The veteran must have served a total of at least 6 months.
- 2) The veteran served for the duration of hostilities regardless of the length of engagement.
- 3) The veteran was discharged on the basis of hardship.
- 4) The veteran was released from active duty because of a service connected disability and was discharged under honorable conditions.

<u>Note</u>: It is **critical** that **each change in rank and title** in your military experience is detailed on either your online application or on the CMS-100 application that you submit. "Lumped" military experience will **not** be credited!

"Time of hostilities with a foreign country" is defined as any period of time in the past, present, or future during which a declaration of war by the United States Congress has been or is in effect or during which an emergency condition has been or is in effect that is recognized by the issuance of a Presidential proclamation or a Presidential executive order and in which the armed forces expeditionary medal or other campaign service medals are awarded according to Presidential executive order.
