



# Are You Interested in a Social Work career with the Illinois Department of Children and Family Services?

**Revised 1-1-10**

The Illinois Department of Children and Family Services (IDCFS) generally hires candidates in the personnel titles as described below to perform casework/case management services with the children and families it serves. Job responsibilities include services to children in foster care and their natural families, and/or work with intact families whose children have not been removed from their custody, and protective service investigations. Candidates must possess the physical, visual and auditory abilities required to carry out assigned duties, with a valid Drivers license and daily access to a vehicle. Information gathered during the background investigation phase may be utilized when selecting an applicant for hire. Conditional Employment Requirements: A background investigation is conducted on all applicants selected for hire. This process involves a check of indicated perpetrators in CANTS (Child Abuse and Neglect Tracking System), Sex Offenders Registry and a fingerprint based criminal check of the Illinois State Police and the Federal Bureau of Investigations. In addition, drug testing, employment reference checks and educational verifications are conducted. **Send all applications c/o IDCFS, Selection and Recruitment 406 E. Child Welfare Specialist	Performs a variety of casework intervention and case management functions related to the welfare of families and children who are in foster care or have remained home (intact families). Duties are performed in an independent manner. Problem cases are referred to the M.S.W. qualified supervisor or Child Welfare Advanced Specialist for assistance and technical oversight. Related human services degree refers to psychology, psychiatric nursing, psychiatry, pastoral counseling, Sociology, Social Services, Social Science, Public Administration, Pastoral Care, Master of Divinity, Human Service Administration, Human Development Counseling, Home Economics – Child and Family Service, Guidance and Counseling, Early Childhood Development, Child, Family and Community Services and Human Services.

2. Related professional experience refers to casework/case management experience related to families and/or children, reunification, adoption, youth development, counseling and advocacy services.

Office Associate, Opt. 2	Performs a variety of complex, specialized clerical information and assistance, typing, record processing, and secretarial and general office support functions.	Requires knowledge, skill and mental development equivalent to completion of high school and two years of office experience.	\$2695 – \$3564	Candidates from CMS eligibility list are invited for interviews when vacancies in the county occur and after bargaining unit rights have been exhausted.
Day Care Licensing Representative II	Performs responsible licensing, monitoring investigative and enforcement functions in the day care licensing program as formulated by the agency.	Requires a bachelor's degree from an accredited college or university with specialization in early childhood education or child development.
